The PV GreenCard is an as-built report issued to the Solar PV system owner by a certified PV GreenCard installation company upon the completion of a solar PV installation. The PV GreenCard is issued digitally via the PV GreenCard web interface.

Clients will receive an email containing a document checklist of documents that must be submitted to the client by the certified PV GreenCard installation company before the PV GreenCard can be issued for the system. The checklist includes installed equipment manuals, the certificate of compliance and system design information. Once the client is satisfied that all the required documents has been submitted, the installation company may issue the PV GreenCard.

Certified PV GreenCard installation companies meet the regulatory requirements in terms of the Occupational Health and Safety Act (OHSA) and the Electrical Installation Regulations to perform electrical installation works in South Africa, Furthermore certified PV GreenCard Installation companies have the necessary training, skill and competency to design, install and commission solar PV systems that are electrically safe, legal and meet supplier requirements. Only Certified PV GreenCard installation companies can issue the PV GreenCard As-Built report.
